AMENDMENTS

With effect from the Effective Date, the reference to 50% (fifty percent) in the definition of "Financial Covenant" in Condition 9.6.7(a), being the Redefine Group Loan to Value Ratio, is amended to 55% (fifty five percent) for the financial year ending 31 August 2020 and the financial half year ending 28 February 2021, and shall revert to 50% (fifty percent) for the financial year ending 31 August 2021 and thereafter.
